### **Frequently Asked Questions**

#### Who will attend the summit?

There will be a particular focus on ensuring a high level of attendance from hospital and healthcare providers, both in terms of senior management and procurement professionals. We are mindful that we do not want this to be a conference where attendance is almost entirely supply-side.

We will focus on Europe so far as procurement is concerned, but we will have strong global representation from suppliers.

Within Europe we are planning regional sessions such as German speaking countries (D-A-CH), United Kingdom, Ireland, France, Benelux, Italy, Spain/Portugal, Denmark, Nordics, Eastern Europe.

#### Which language will the summit be held in?

The main onstage language will be English but German and French translation will be available to all.

#### How many people will attend the summit?

We are seeking to confirm 450 attendees. However, the focus will be on securing high-quality decisionmakers rather than volume of attendance.

#### Can I speak at the event?

The Financial Times will consider all speaking applications on an individual basis. However, we will ask some organisations, particularly those in the hospital supply chain, to underpin their speaking involvement with sponsorship.
